Pursuant to N.J.A.C.6A:23A-16.10(c)(4), the Fairfield Board of Education hereby certifies that as of October 31, 2020 after review of the Secretary's monthly financial report for October 2020 (appropriations section), and upon consultation with the appropriate district officials, to the best of our knowledge, no major account or fund has been over expended in violation of N.J.A.C. 6A:23A-16.10(a) and those sufficient funds are available to meet the district's financial obligations.

E. Alyssa's Law Compliance and School Security Grant

F. <u>Submission of a Special Ballot Question</u>

WHEREAS, The Board of Education (the "Board" when referring to the governing body and the "School District" when referring to the territorial boundaries governed by the Board) of the Township of Fairfield in the County of Essex, New Jersey (the "State") seeks to provide for improvements to Adlai E. Stevenson Elementary School and Winston S. Churchill School (collectively, the "Project"); and

WHEREAS, to accomplish the Project, the Board seeks to authorize the submission of a ballot question and an explanatory statement at a special School District election to be held on Tuesday, January 26, 2021 (the "Election") and to authorize certain actions required to be taken in connection with the conduct of the Election and the undertaking of the Project.

NOW, THEREFORE, BE IT RESOLVED by The Board of Education of the Township of Fairfield in the County of Essex, New Jersey (not less than a majority of the full membership of the Board concurring) as follows:

1. The following Explanatory Statement and Proposal (the "Proposal") shall be submitted to the legal voters of the School District at a special School District election (the "Election") to be held on Tuesday, January 26, 2021, commencing at 2:00 p.m. in the School District. The polls shall remain open until 8:00 p.m. and as much longer as may be necessary to permit all the legal voters then present to vote and cast their ballot.

EXPLANATORY STATEMENT

The Project

As set forth in the Proposal below, the Board is seeking to provide the following improvements:

- <u>Adlai E. Stevenson Elementary School</u>: (i) Expansion to provide additional educational space including classrooms and STEAM classroom and (ii) internal renovations to provide technology space, resource rooms, special education classrooms, main office/ administrative space and building upgrades including electrical system and toilet rooms; and
- <u>Winston S. Churchill School</u>: (i) Expansion to provide additional educational space including classrooms; science classrooms, SGI classrooms, STEAM classroom; gymnasium, kitchen and ancillary mechanical, electrical and storage rooms and (ii) internal renovations to provide technology space, special education classrooms, guidance and administrative spaces; main office, nurse's suite, music room, band room and building upgrades including electrical system upgrades, boiler replacement and roof replacement.

While the total Project is budgeted at \$29,740,500, after State Funding, the local cost of the Project is approximately \$26,296,325. The Board will issue school bonds to fund the Project costs over a 25 year period.

State Funding for the Project

The Project is eligible for State funding in the form of debt service aid. The State has awarded debt service aid to the district in an amount equal to 40% of "final eligible costs" of the Project, which aid equates to 11.5% of the total costs of the Project. SUCH STATE FUNDING IS ONLY AVAILABLE IF THE PROPOSAL PASSES.

PROPOSAL

The Board of Education of the Township of Fairfield in the County of Essex, New Jersey is authorized to undertake the following in order to provide additional educational space, safety/security improvements, upgraded educational space, and health/safety improvements: (A) expansion and renovations to the Adlai E. Stevenson Elementary School to provide additional educational space including classrooms and STEAM classroom and (ii) internal renovations to provide technology space, resource rooms, special education classrooms, main office/administrative space and building upgrades including electrical system and toilet rooms and; (B) expansion and renovations to the Winston S. Churchill School to provide additional educational space including classrooms; science classrooms, SGI classrooms, STEAM classroom; gymnasium, kitchen and ancillary mechanical, electrical and storage rooms and (ii) internal renovations to provide technology space, special education classrooms, guidance and administrative spaces; main office, nurse's suite, music room, band room and building upgrades including electrical system upgrades and roof replacement. The Board is authorized to expend on such project an amount not to exceed \$29,740,500 which expenditure shall be funded with bonds of the School District. The State has agreed to provide debt service aid of 40% of the final eligible costs. The final eligible costs are \$8,610,438. The project includes \$4,859,912 school facilities construction elements in

addition to the facilities efficiency standards developed by the Commissioner of Education, or that are not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The local shares of each of the projects may be transferred among projects.

- 2. The Board hereby approves and adopts the Proposal and, subject to the approval of the legal voters of the School District, hereby determines to carry out the same.
- 3. The Business Administrator/Board Secretary is hereby authorized and directed, in conjunction with Bond Counsel, to deliver a certified copy of this resolution and such other information as shall be necessary to comply with applicable provisions of the Education Law and Election Law, to the Executive Essex County Superintendent of Schools, Essex County Clerk, Essex County Board of Elections, and to the Clerk of the Township of Fairfield, and to request such persons to undertake their respective functions under the Education Law and the Election Law, as applicable, in connection with the Election. The Business Administrator/Board Secretary is hereby authorized to amend the Proposal and the Explanatory Statement to conform same to statutory requirements.
- 4. The Board hereby acknowledges and confirms that, in accordance with the requirements of Sections 24-16 and 24-17 of the Education Law, a Supplemental Debt Statement has been prepared as of the date of this resolution by the Chief Financial Officer of the Township of Fairfield, giving effect to the proposed total authorization of School Bonds of the School District in the maximum amount provided for in the Proposal, and that such Supplemental Debt Statement has been filed in the office of the Clerk of the Township of Fairfield, and in the office of the Business Administrator/Board Secretary prior to the adoption of this resolution. The Board hereby directs the Business Administrator/Board Secretary to cause such Supplemental Debt Statement to be filed in the office of the Director of the Division of Local Government Services, New Jersey Department of Community Affairs prior to the date of the Election.
- 5. The School Administration and such other officers, professionals and agents of the Board as are necessary, including Wilentz, Goldman & Spitzer, P.A., Bond Counsel and the Architects for the Project, are each hereby authorized and directed to perform such acts, execute such documents and do such things as are necessary and proper for the submission of the Proposal to the voters of the School District at the Election, including preparation and submission of all required applications for receipt of the State debt service aid.
- 6. The Board hereby (i) accepts the determination of Preliminary Eligible Costs as set forth in the letters of the New Jersey Department of Education (the "NJDOE Eligibility Letters"); (ii) elects to receive the State Share in the form of debt service aid; (iii) determines to construct the Project; (iv) agrees to locally fund any excess costs and (v) delegates the supervision of the Project to the Business Administrator/Board Secretary.
- 7. This resolution shall take effect immediately.

XI. COMMITTEE REPORTS

Brian Egan thanked the administrators, auditors, and the Business Administrator, Lyanna Rios, for an audit with no recommendations.

XII. PUBLIC COMMENTS: NON-AGENDA ITEMS ONLY

Danielle Tauthong, 8 Boxwood Drive, requested that an email be sent reminding the community of upcoming board meetings. She also stated that there is confusion in the way the half days are listed on the calendar.

Rose Laprus, 12 Bates Drive, asked about the maximum functional capacity at each building and if the cost of the referendum project includes any other expenses. (via chat) She also asked about the budgeted cost per sq. foot as compared to the \$143 the state allows?

Melissa Clausi, 25 Donna Drive, questioned whether or not an expansion is necessary if there is a current decrease in enrollment. She also asked if there is a separate budget for staffing needs as a result of expansion. Lastly, she asked if there is an alternate plan if restrictions do not change for the remainder of the school year.

Lek Tauthong, 8 Boxwood Drive, questioned the relationship between the Board of Education and the Township of Fairfield. A lot of office space is being converted to residential. He also asked if the district is doing a study to accommodate mixed-use housing?

Tara Medina, 242 Big Piece Road, asked about the difference between the current tax rate and the \$48 average tax impact as a result of the referendum. She also asked what interest rate was used for this calculation? District Bond Counsel, Lisa Gorab, explained that the information was based on the tax impact analysis provided by the district's financial advisor.

Theresa Carmagnola, 5 Francavilla Drive, (via chat): What percentage increase is the \$48 assessment to the taxpayer compared to what we currently pay?

Lisa Ivers, 16 John Street, (via chat): What is the anticipated start of construction and the estimated schedule to complete construction? John Mooney's response was unfortunately, the Township has the old format of the 2020 budget on the website, and it does not include the page that breaks down the taxes collected for municipal, school, and county taxes. That information is either on hand with the financial advisor, or can be obtained directly from the Township Tax Assessor's office.

Karen Loucas, 250 Horseneck Road, (via chat): Are we closed due to cases rising in town or are there positive cases in Stevenson? Rumor is the Churchill email says a staff member tested positive so I was wondering if it was the same for Stevenson? Dr. Ciccotelli responded that Stevenson is currently experiencing staffing issues.

Grossi, 25 Phyllis Lane (via chat): In regards to the current virtual schedule, what is the likelihood that we will be going back to school early December due to staffing issues and can you disclose what those issues are? And if we do not go back on the dates that are posted, can we know earlier than 24 hours in advance for working parents' schedules?
